ORDINANCE NO. 16-07

AN ORDINANCE AMENDING CHAPTER 6 AND CHAPTER 29 OF THE VILLAGE OF DUPO, ILLINOIS'
REVISED CODE OF ORDINANCES

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on September 6, 2016 at 7:00 pm, before the Village Board of Dupo and notice of said meeting was duly given; and

WHEREAS, it was brought before the Village Board that it would be in the best interests of the Village of Dupo to consider a reorganization of two sections of Chapter 29, specifically, Sections 29-1-52 and 29-1-54; and

WHEREAS, Sections 29-1-52 and 29-1-54 are to be removed from Chapter 29 and re-inserted in Chapter 6, Building Code, as the Village Board deems the provisions contained in those sections to be more germane and better identified to Chapter 6, which pertain to the Village's Building Code; and

WHEREAS, the Mayor and the Board of Trustees desire that Section 29-1-52 be removed from Chapter 29, in its entirety, and inserted in Chapter 6 as newly created Article II—Building Code, specifically Section 6-2-1—Adoption of Building Code; and

WHEREAS, the Mayor and the Board of Trustees desire that Section 29-1-54 be removed from Chapter 29, in its entirety, and inserted in Chapter 6 as newly created Article III—Fees, specifically Section 6-3-1—Fee Schedule; and

WHEREAS, that the now Sections 29-1-52 and 29-1-54 be labeled as "RESERVED" for their future use; and

WHEREAS, the Mayor and the Board of Trustees believe that the aforementioned changes to be in the best interests of the Village and its citizens; and

WHEREAS, the Village Board of Dupo, Illinois has recommended the approval of said amendments to its Revised Code of Ordinances of Dupo, Illinois to reflect this reorganization of its Code;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS:

Section 1: Recitals. The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

Section 2: Amendment. This request for an amendment to Chapters 6 and 29, of the Village's Revised Code of Ordinances, specifically Section 29-1-52 shall be moved, in its entirety, to Chapter 6 and inserted into the newly created Article II (Building Code) and re-labeled as Section 6-2-1—Adoption of Building Code; Section 29-1-54 shall be moved, in its entirety, to Chapter 6 and inserted into the newly created Article III (Fees) and re-labeled as Section 6-3-1—Fee Schedule; and Sections 29-1-52 and 29-1-54 shall be now labeled as "RESERVED." This Amendment is APPROVED. The Revised Code of Ordinances of Dupo, Illinois shall reflect such amendments.

Section 3: Severability of Provisions. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.


Section 4: Conflict. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5: Effective. This Ordinance shall take full force and effect immediately upon passage by the Village Board of Trustees.


