**AN ORDINANCE AUTHORIZING THE VILLAGE MAYOR TO ENTER INTO AN AGREEMENT TO
PURCHASE A USED 2015 ZERO-TURN HUSTLER MOWER FOR \$4,000.00
FOR THE VILLAGE AND VILLAGE STREET DEPARTMENT'S USE**

WHEREAS, the Village of Dupu, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupu, Illinois at the Dupu Village Hall, 107 N. Second Street, on August 7, 2017 at 7:00 p.m., before the Village Board of Dupu; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupu is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

WHEREAS, the Corporate Authorities of the Village of Dupu, Illinois desire to purchase a used (260 hours) 2015 zero-turn Hustler mower (Serial #08050990 and Model #928432) for \$4,000.00 from Bob Brockland for the Village and Village Street Department's use; and

WHEREAS, the aforementioned Hustler zero-turn mower shall be used for public purposes by the Village of Dupu and its Street Department; and

WHEREAS, it is necessary that an agreement be entered into in order to purchase said Hustler zero-turn mower; and

WHEREAS, funds are currently available for the purchase of said Hustler zero-turn mower; and

WHEREAS, the Corporate Authorities of the Village of Dupu, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of the aforementioned Hustler zero-turn mower for \$4,000.00 from Bob Brockland for use by the Village of Dupu and its Street Department; and

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:


1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
2. That the Village of Dupo, Illinois is to purchase a used (260 hours) 2015 zero-turn Hustler mower (Serial #08050990 and Model #928432) for \$4,000.00 from Bob Brockland.
3. That the Mayor of the Village of Dupo, Illinois is hereby authorized to purchase the aforementioned zero-turn Hustler mower for \$4,000.00 for the Village of Dupo, Illinois, on behalf of the Village from Bob Brockland.
4. That the Mayor of the Village of Dupo, Illinois, and on behalf of the Village shall execute such documents necessary for the purchase of said zero-turn Hustler mower.
5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information as may be required to accomplish the purchase of the aforementioned zero-turn Hustler mower for \$4,000.00.

PASSED this 7th day of August, 2017 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.


