

**RESOLUTION NO. 17 - 08**

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, IL, TO AUTHORIZE  
THE VILLAGE MAYOR TO ENTER INTO AGREEMENTS TO PURCHASE A  
2017 CATERPILLAR BACKHOE LOADER, MODEL 420F2 FOR \$61,050.00,  
FOR THE VILLAGE AND VILLAGE STREET DEPARTMENT USE**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on July 17, 2017 at 7:00 p.m., before the Village Board of Dupo; and

**WHEREAS**, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois desire to purchase a 2017 Caterpillar backhoe loader, model 420F2 for \$61,050.00 for the Village and Village Street Department use; and

**WHEREAS**, the aforementioned 2017 Caterpillar backhoe loader shall be used for public purposes by the Village of Dupo and its Street Department; and

**WHEREAS**, it is necessary that agreements be entered into in order to purchase said backhoe loader; and

**WHEREAS**, funds are currently available for the purchase of the 2017 Caterpillar backhoe loader; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of a 2017 Caterpillar backhoe loader for use by the Village of Dupo and its Street Department; and

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**


1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
2. That the Village of Dupo, Illinois is to purchase a 2017 Caterpillar backhoe loader, model 420F2 for \$61,050.00.
3. That the Mayor of the Village of Dupo, Illinois is hereby authorized to purchase a 2017 Caterpillar backhoe loader, model 420F2 for \$61,050.00 for the Village of Dupo, Illinois, on behalf of the Village.
4. That the Mayor of the Village of Dupo, Illinois, and on behalf of the Village shall execute such documents necessary for the purchase of said backhoe loader.
5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information as may be required to accomplish the purchase of a 2017 Caterpillar backhoe loader, model 420F2 for \$61,050.00.


