ORDINANCE NO. 17-11

AN ORDINANCE TO AUTHORIZE THE VILLAGE OF DUPO, ILLINOIS TO ENTER INTO A FEE AGREEMENT WITH THE LAW FIRM OF BOYLE BRASHER, LLC OF BELLEVILLE, ILLINOIS, TO PROVIDE LEGAL SERVICES TO THE VILLAGE OF DUPO, ILLINOIS FOR THE VILLAGE'S 2017 and 2018 FISCAL YEAR

WHEREAS, the Village Council of the Village of Dupo, Illinois (the "Village") has found and determined and does hereby declare that it is in the Village's best interests and appropriate to enter into a fee agreement with the law firm of Boyle Brasher, LLC of Belleville, Illinois ("Boyle Brasher") to provide legal services to the Village; and

WHEREAS, it is necessary and appropriate that this Ordinance be enacted for the purpose of approving such fee agreement for Boyle Brasher to provide legal services to the Village.

NOW, THEREFORE, BE IT ORDAINED, by the Village Council of the Village of Dupo, Illinois, as follows:

<u>Section 1.</u> The recitals contained above in the preamble of this Ordinance are hereby incorporation herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the Village council of the Village of Dupo, Illinois.

Section 2. The Village Council of the Village of Dupo, Illinois, does hereby authorize and direct the Mayor to execute and deliver one or more document(s) entitled "Village of Dupo Fee Agreement – Fiscal Year 2017 and 2018" ("Fee Agreement"), in the form attached hererto as Exhibit "A", acknowledging and approving the fees to be charged by Boyle Brasher in providing legal services to the Village, which Fee Agreement is hereby approved as to form, in as many counterparts as the Mayor shall determine, and the Village Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the Village.

<u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

VILLAGE OF DUPO FEE AGREEMENT FISCAL YEAR 2017 and 2018

The following are the general terms of the Fee/Cost Agreement between the Village of Dupo, Illinois ("Village"), and the law firm, Boyle Brasher, LLC ("Law Firm") for the Village's fiscal year beginning on July 1, 2017 and ending on December 31, 2018.

RETAINER:

\$3,500.00 Per Month

Covers:

- Two (2) Village Council Meetings per month
- One (1) Staff Meeting per month
- Up to Four (4) other meetings per year (e.g., Committee Meetings, Zoning Board, Plan Commission).
- Preparation for said Village Council Meetings, Staff Meetings and all other meetings covered by the retainer.
- Telephone calls, emails and other similar modes of communication with the Mayor, Members of the Village council, the Village Clerk, Village Administrator and Department Heads.
- Ordinance and Resolution Review: Routine Ordinances and Resolutions that are prepared initially by Village Staff and reviewed by counsel.
- Routine Ordinance and Resolution Preparation: Up to two (2) per Council Meeting.

HOURLY:

\$195.00 plus costs and expenses (Charles J. Swartwout)

\$175.00 plus costs and expenses (David Schneidewind)

\$145.00 plus costs and expenses (Associates) \$125.00 Traffic Matter Appearances by Attorney

\$ 50.00 Paralegal

Covers:

- All Village litigation; negotiations beyond Council discussions; labor contracts, negotiations and grievances; special contracts, e.g., sale of Village owned properties, real estate acquisitions or sale.
- Special Projects that are not large: subdivision or engineering related matters.

<u>LARGE PROJECTS</u>: Generally large tract real estate developments including but not limited to work related to an Intergovernmental Agreement, Boundary issues annexation, TIF projects, and in circumstances where Developer Reimbursement Agreements are negotiated.

- Court Related Expenses: Filing fees and costs, including expert fees, witness fees, travel expenses and deposition and transcript fees and costs.
