

RESOLUTION NO. 17-15

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, IL, TO AUTHORIZE THE VILLAGE MAYOR TO ACCEPT MOEHLE CONSTRUCTION'S PROPOSAL FOR THE PROVIDING OF LABOR FOR THE ERECTING OF A BUILDING ADDITION FOR
THE VILLAGE'S GAS DEPARTMENT**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on November 6, 2017 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois believe it necessary and in the Village's best interests to construct an addition to the Village's Gas Department's gas shop;

WHEREAS, the Village procured a bid for the providing of wage labor from Moehle Construction of 26414 College Road, Centralia, Illinois for the erection of a 32 ft. x 70 ft. x 14 ft. addition to the Gas Department's gas shop in the amount of \$18,655.00, see Exhibit "A" attached hereto, bid of Moehle Construction dated 9-21-17, and incorporated as if fully set forth herein;

WHEREAS, the bid is under the threshold amount (\$25,000.00) requiring bidding of work pursuant to 65 ILCS 5/8-9-1, and the Village Revised Code of Ordinances 1-2-27, which such bidding may be waived by a vote of 2/3 of the Trustees holding office;

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchasing of the wage labor from Moehle Construction by the Village for the erection of a 32 ft. x 70 ft. x 14 ft. addition to Gas Department's gas shop, and authorizing the Mayor to enter into any agreement to effectuate such, and to the extent required, waiving by a 2/3 vote any bidding requirements pursuant to state statute or Village code; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as

recommendations of the Village Board of Trustees of the Village of Dupou, Illinois.

2. That the Mayor on behalf of the Village of Dupou, Illinois is hereby authorized to accept the proposal from Moehle Construction for the providing of wage labor for the erection of a 32 ft. x 70 ft. x 14 ft. addition to the Gas Department's gas shop in the amount of \$18,655.00 as indicated in Exhibit "A" and pursuant to the terms and conditions contained therein.
3. That the Mayor of the Village of Dupou, Illinois, on behalf of the Village, and the Village Clerk to seal, if necessary, are hereby authorized to execute any necessary agreement between the Village and Moehle Construction for the providing of wage labor for the construction of the building addition as referenced in Exhibit "A" to this Resolution.
4. That the Mayor and Village Clerk of the Village of Dupou, Illinois are further authorized to take any such other action as may be required to accomplish the providing of wage labor for the aforementioned building addition.

PASSED this 6th day of November, 2017 by the Village Mayor and the Village Board of Trustees of the Village of Dupou, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
