ORDINANCE NO. 18-03

AN ORDINANCE AUTHORIZING THE DESIGNATION OF THE 200 BLOCK OF SOUTH 2nd STREET IN THE VILLAGE OF DUPO, ILLINOIS AS A ONE-WAY STREET AND THE PLACEMENT OF SIGNS DESIGNATING SUCH AND THE DESIGNATION AND PLACEMENT OF NO PARKING SIGNS ON BOTH SIDES OF THE 200 BLOCK OF SOUTH 2nd STREET

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on January 16, 2018 at 7:00 pm, before the Village Board of Dupo and notice of said hearing was duly given; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-208 to designate streets within the Village as one-way and place such signs designating such, and the Village may regulate the standing or parking of vehicles within the Village limits; and

WHEREAS, the Village has enacted a Revised Code of Ordinances, and pursuant to Chapter 24, Motor Vehicle Code, section 24-3-2 the Village can designate streets or alleys by ordinance, and such are listed in Schedule "B" to Chapter 24; and

WHEREAS, pursuant to section 24-3-5 of the Village's Revised Code of Ordinances the Village may post appropriate signs designating all one-way streets; and

WHEREAS, pursuant to section 24-6-3 of the Village's Revised Code of Ordinances the Village may designate certain areas within its Village limits as "no parking" and designate such by appropriate signage, and such locations are listed in Schedule "F" to Chapter 24; and

WHEREAS, the Village has determined that the designation of the 200 block of South 2nd Street as a one-way street in an easterly direction from South Main to the intersection of South 2nd Street and Kroeger Avenue and the placement of appropriate signs designating such is in the best interest of the health, safety, and welfare of the citizens of Dupo, Illinois; and

WHEREAS, the Village has determined that the designation of the 200 block of South 2nd Street as "no parking" on either side of the street and the placement of appropriate signage is in the best interest of the health, safety, and welfare of the citizens of Dupo, Illinois; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The aforementioned recitals are hereby adopted as findings by the

Village Board, and incorporated herein.

Section Two: The designation of the 200 block of South 2nd Street as a one-way street in an easterly direction from South Main to the intersection of South 2nd Street and Kroeger Avenue and the placement of appropriate signs designating such is in the best interest of the health, safety, and welfare of the citizens of Dupo, Illinois.

Section Three: The designation of the 200 block of South 2nd Street as "no parking" on either side of the street and the placement of appropriate signage is in the best interest of the health, safety, and welfare of the citizens of Dupo, Illinois.

Section Four: Schedules "B" and "F" of Chapter 24 of the Village's Revised Code of Ordinances are hereby amended accordingly pursuant to the above additions.

Section Five: The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section Six: This Ordinance shall be in full force and effect from and after its passage and approval.
