ORDINANCE NO. 18-04

AN ORDINANCE AUTHORIZING THE CONSTRUCTION AND INSTALLATION OF A SPLASH PAD AND THE VILLAGE MAYOR TO ENTER INTO A LOAN AGREEMENT WITH FIRST NATIONAL BANK OF WATERLOO TO PROVIDE PARTIAL FINANCING OF THE SPLASH PAD AND A CONTRACT FOR THE CONSTRUCTION AND INSTALLATION WITH CAPRI POOLS AND ACQUATICS

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed meeting, that was open to the public, was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on February 5, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to lease real and personal property, which includes equipment, for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through installments to be made at stated intervals during a certain period of time, but, in no case, shall such contracts provide for consideration to be paid during a period of time in excess of 20 years nor shall such contracts provide for the payment of interest at a rate of more than that permitted by statute; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois have previously approved the construction and installation of a splash pad in the Village and have obtained a partial grant for the same from the St. Clair County Parks Grant Program; and

WHEREAS, Capri Pools and Aquatics ("Capri") can construct and install the splash pad for \$269,310.00; and

WHEREAS, the Village desires to contract with Carpi for the construction and installation of the splash pad; and

WHEREAS, the Village needs to secure additional funding for the construction and installation of the splash pad in the amount of \$100,000.00, and the First National Bank of Waterloo can provide said funding at an Annual Percentage Rate of 3.00% for the term of five (5) years (60 months) at a monthly payment of \$1,770.59;

WHEREAS, the Village desires to enter into a loan agreement with the First National Bank of Waterloo to provide additional funding for the splash pad;

WHEREAS, the construction and installation of the splash pad will benefit the public and citizens of the Village of Dupo, it shall be used for public purposes, and will be in the best interests of the public health and welfare;

WHEREAS, it is necessary that agreements be entered into for the construction and installation of the splash pad, including but not limited to an agreement with Capri for construction and installation and a loan agreement with First National Bank of Waterloo for partial financing of the project; and

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

- 1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois is to construct and install a splash pad in the Village of Dupo at a cost of \$269,310.00, and the construction and installation shall be undertaken on behalf of the Village by Capri.
- 3. That the Mayor of the Village of Dupo, Illinois, and on behalf of the Village is hereby authorized to enter into a contract/agreement with Capri for the construction and installation of the splash pad.
- 4. That the Village of Dupo, Illinois has obtained partial financing of the splash pad project through the St. Clair County Park Grants Program, and an additional \$100,000.00 must be financed through a loan with the First National Bank of Waterloo at the Annual Percentage Rate of 3.00% for a term of five (5) years (60 months) at a monthly payment of \$1,770.59.
- 4. That the Mayor of the Village of Dupo, Illinois, and on behalf of the Village, is hereby authorized to enter into a loan agreement with the First National Bank of Waterloo at the Annual Percentage Rate of 3.00% for a term of five (5) years (60 months) at monthly payment of \$1,770.59, for the partial financing of the Village's splash pad.
- 5. That the Mayor of the Village of Dupo, Illinois is hereby authorized to provide any such additional information and take any other

further action in conformance herewith to effectuate the contract/agreement with Capri for the construction and installation of the splash pad, and for the loan agreement with First National Bank of Waterloo for the splash pad, which may be required.
