AN ORDINANCE RECONFIRMING, REINSTITUTING AND ADOPTING A GAS FRANCHISE FEE FOR THE VILLAGE OF DUPO, ILLINOIS

WHEREAS, the Village of Dupo, St. Clair County, Illinois ("Village"), is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on February 5, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, previously the Village had adopted section 17-3-7 of the Village's Revised Code of Ordinances regarding "Rules & Regulations" pertaining to the Village's Gas System; and

WHEREAS, section 17-3-7 provided that "the Gas Department shall pay a franchise fee of Three Thousand Dollars (\$3,000.00) per month Thirty-Six Thousand Dollars (\$36,000.00) in total to the Village General Fund in a lump sum payment, once each year at the beginning of the fiscal year, no later than May 31st of each fiscal year;" and

WHEREAS, it has come to Village Board's attention that the aforementioned "franchise fee" set forth in section 17-3-7 may have been struck or discontinued by past actions of the Village; and

WHEREAS, the Village Board deems that such "franchise fee" should be reconfirmed, reinstituted and adopted as part of the current Revised Code of Ordinances of the Village, specifically section 17-3-7; and

WHEREAS, the Village Board deems the "franchise fee" contained in the amended section 17-3-7 to be payable by the Gas Department to the Village for the Village's fiscal year 2017 and thereafter as provided in said section; and

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

Section 1: The facts and statements contained in the foregoing recitals are incorporated herein as findings of the Corporate Authorities.

Section 2: Chapter 17, Article III, Section 17-3-7, shall be reinstituted and shall read and be amended as follows:

17-3-7 RULES AND REGULATIONS. The Village is authorized to impose reasonable terms and conditions upon the furnishing of gas service and reasonable rules and regulations in the operation and conduct of its business including, but not limited to, the requiring of a reasonable deposit of any customer as a condition of furnishing gas to such consumer. As a part of these reasonable terms and conditions the Gas Department shall pay a franchise fee of Three Thousand Dollars (\$3,000.00) per month Thirty-Six Thousand Dollars (\$36,000.00) in total to the Village General Fund

in a lump sum payment, once each year at the beginning of the fiscal year, no later than May 31st of each fiscal year.

Section 3: The "franchise fee" contained in the amended section 17-3-7 is to be payable by the Gas Department to the Village for the Village's fiscal year 2017, and thereafter as provided in said section.

Section 4: Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

Section 5: All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6: This Ordinance shall take full force and effect immediately upon passage by the Village Board of Trustees.
