

RESOLUTION NO. 18-03

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS TO
AUTHORIZE THE VILLAGE MAYOR TO ENTER INTO AN AGREEMENT WITH
BROCK INDUSTRIAL SERVICES FOR REMOVAL OF CERTAIN MATERIALS
FROM THE VILLAGE'S OLD GAS DEPARTMENT BUILDING**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on February 5, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, it has come to the attention of Village that certain materials in the Village's Old Gas Department Building located at 720 North 2nd Street may be asbestos-containing materials; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desire to have said materials abated and removed from said premises; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois desires to enter into an agreement for abatement and removal of any possible asbestos-containing materials located at the Village's Old Gas Department Building with Brock Industrial Services of Sauget, Illinois for \$10,553.00, a copy of the bid is attached hereto as **Exhibit A**, and incorporated herein by reference; and

WHEREAS, it is necessary that certain agreements/contracts be entered into in order to obtain said abatement and removal services from Brock Industrial Services; and

WHEREAS, funds are currently available for these services; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize entering into an agreement for asbestos abatement and removal at the Old Gas Department building with Brock Industrial Services; and


NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupu, Illinois.
2. That the Village of Dupu, Illinois is authorized to enter into an agreement for asbestos abatement and removal at the Village's Old Gas Department Building with Brock Industrial Services of Sauget, Illinois for \$10,553.00, as indicated and set forth in **Exhibit A**, attached hereto and incorporated herein by reference.
3. That the Mayor of the Village of Dupu, Illinois, on behalf of the Village, is hereby authorized to enter into an agreement with Brock Industrial Services for \$10,553.00.
4. That the Mayor of the Village of Dupu, Illinois, and on behalf of the Village shall execute such documents necessary to enter into an agreement with Brock Industrial Services for the aforementioned services outlined in **Exhibit A**.
5. That the Mayor of the Village of Dupu, Illinois is authorized to provide any such additional information and take such other action as may be required to enter into an agreement for asbestos abatement and removal services at the Old Gas Department building With Brock Industrial Services.

SCOPE OF WORK

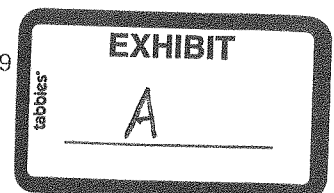
- 1.) Brock Industrial will provide material and labor to abate 1,800SF of Transite siding located at 720 North 2nd street in the Village of Dupo. The price below includes removal, disposal and bulk Sampling of all 1,800SF of the Asbestos containing material.

PRICING

T&M Budget Price ----- \$10,553
Includes all labor, supervision, material, freight, payroll taxes, insurance, overhead and profit.

CLARIFICATIONS

- 1.) Work to be done in accordance with NMAPC Agreement.
- 2.) Pricing is based on working Straight Time, non-holiday, weekdays.
- 3.) Any changes and/or delays will be billed at Time & Material rates.
- 4.) Five (5) days notice is required to mobilize and start installation.
- 5.) All work to be performed exclusively by union craft.
- 6.) Suitable material storage and/or lay down area is to be provided within a reasonable distance from the work area.
- 7.) While work is being performed by us, access to the area should be limited to authorized personal, unless previous arrangements have been made.
- 8.) Pricing does not include sales tax
- 9.) Proposal is based upon mutually agreeable terms and conditions



CLARIFICATIONS CONTINUED

- 7.) Forklift and Operator to be furnished by Contractor
- 8.) Crane and Operator to be furnished by Contractor
- 9.) Site orientation/training is included.
- 10.) Drug testing is not included.
- 11.) The customer is to provide and pay for all permits, conditions and costs required and/or imposed by the City and/or County.
- 12.) Drawing to be submitted after award of contract.
- 13.) All drawings furnished by Brock Industrial Services are proprietary and are not to be copied and/or utilized for other reasons unless otherwise expressly stated in writing by Brock Industrial Services.
- 14.) Payment Terms: Progressive billing, due 30 days from date of invoice.
- 15.) Payment Terms: 70% upon installation and 30% upon removal.
Payments due 30 days from date on invoice.
- 16.) Pricing is current as of the date of this letter and is subject to change according to Union negotiations and/or any statutory changes in taxes and insurances.
- 17.) The terms and conditions of this quote are valid for 60 days.
