**ORDINANCE NO. 18 - 06**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS  
AUTHORIZING THE PURCHASE A 2019 FREIGHTLINER 108SD TRUCK**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on February 5, 2018 at 7:00 p.m., before the Village Board of Dupo; and

**WHEREAS**, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desires to purchase a 2019 Freightliner 108SD truck for \$112,783.00 from Truck Centers, Inc. for the Village and its departments' use; and

**WHEREAS**, the aforementioned 2019 Freightliner 108SD truck shall be used for public purposes by the Village of Dupo and its departments; and

**WHEREAS**, the purchase of the 2019 Freightliner 108SD truck shall be financed with First National Bank of Waterloo for a period of 84 months at an interest rate of 4.5% with monthly payments of \$1,551.00 to be split across all Village departments; and

**WHEREAS**, it is necessary that certain agreements/contracts be entered into with Truck Centers, Inc. and First National Bank of Waterloo in order to purchase said truck; and

**WHEREAS**, pursuant to Section 1-2-27 of the Village's Revised Code of Ordinances bidding for the aforementioned truck and financing was waived by a vote of two-thirds (2/3) of the Trustees holding office; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of a 2019 Freightliner 108SD truck for use by the Village of Dupo and its departments; and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:


1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
2. That the Village of Dupo, Illinois is authorized to purchase a 2019 Freightliner 108SD truck in the amount of \$112,783.00 from Truck Centers, Inc.
3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase a 2019 Freightliner 108SD truck in the amount of \$112,783.00 from Truck Centers, Inc. for the Village of Dupo, Illinois.
4. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to finance the purchase of the 2019 Freightliner 108SD truck with the First National Bank of Waterloo for a period of 84 months at an interest rate of 4.5% with monthly payments of \$1,551.00 to be split across all Village departments.
5. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase of said truck, including but not limited to those contracts or agreements with Truck Centers, Inc. and First National Bank of Waterloo.
6. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase of the 2019 Freightliner 108SD truck in the amount of \$112,783.00 from Truck Centers, Inc.


