# RESOLUTION NO. 18-17

# A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS, TO PURCHASE WATER MAIN MATERIALS AND SUPPLIES FOR THE LOUISA STREET WATER MAIN PROJECT

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on May 21, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, the Village of Dupo is currently undertaking a water main project on Louisa Street in the Village of Dupo, Illinois, and necessary materials and supplies are required to complete the project; and

WHEREAS, the Village of Dupo received three bids from suppliers who sell and supply the necessary materials and supplies for the Louisa Street water main project; and

WHEREAS, the lowest bid received was from Schulte Supply, Inc. of Edwardsville, Illinois in the amount of \$23,113.59 (see Exhibit "A" attached hereto bid from Schulte Supply, Inc.); and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois believe it necessary and in the Village's bests interests to complete the Louisa Street water main project and purchase the necessary materials and supplies from the lowest bidder Schulte Supply, Inc.; and

WHEREAS, the Village of Dupo, Illinois desires, and to the extent applicable, to use TIF funds to purchase materials and supplies for improvements in the Village of Dupo, Illinois, including the aforementioned materials and supplies for the Louisa Street water main project; and

WHEREAS, the Village of Dupo, Illinois desires to award the bid for the purchase of supplies and materials from Schulte Supply, Inc. for the Louisa Street water main project; and

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. The Village Board of Trustees hereby approves the awarding of the purchase of

materials and supplies for the Louisa Street water main project to Schulte Supply, Inc. of Edwardsville, Illinois in the amount of \$23,113.59 (see attached Exhibit "A").

- 3. The Village Board of Trustees hereby authorizes and directs the Mayor to execute, and if necessary, the Village Clerk to seal on behalf of the Village, all documents necessary to effectuate the purchase the materials and supplies (Exhibit "A") from Schulte Supply, Inc. of Edwardsville, Illinois.
- 4. The Village Board of Trustees hereby authorizes the Mayor to take such additional actions as may be required or necessary to carry out and complete the purchase of the materials and supplies (Exhibit "A") from Schulte Supply, Inc. of Edwardsville, Illinois.
- 5. This Resolution shall be in full force and effect from and after its passage, as provided by law.
