AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS AUTHORIZING THE PURCHASE OF A TAKEUCHI TB235-2CR EXCAVATOR WITH 18" TOOTH BUCKET

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on November 19, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

WHEREAS, the Village of Dupo desires to purchase an excavator of the required specifications for the Village's use; and

WHEREAS, the Village of Dupo received bids for the purchase of a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment and after due consideration of all submitted bids, the Village authorities have determined that Bobcat of St. Louis, Fairview Heights, Illinois has submitted the lowest and most responsible bid to supply a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment to the Village for public purpose; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desire to purchase a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment for \$48,277.00 from Bobcat of St. Louis, Fairview Heights, Illinois, as referenced in Exhibit A attached hereto, for the Village and its departments' use; and

WHEREAS, the aforementioned Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment shall be used for public purposes by the Village of Dupo and its departments; and

WHEREAS, the purchase of the Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment shall be paid for with a single installment of the full contract price with money from the Village's General Funds; and

WHEREAS, it is necessary that certain agreements/contracts be entered into with Bobcat of St. Louis, Fairview Heights, IL and the Village of Dupo in order to purchase said piece of equipment; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment for use by the Village of Dupo and its departments; and

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

- 1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois is authorized to purchase a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment in the amount of \$48,277.00 from Bobcat of St. Louis, Fairview Heights, Illinois as indicated in the attached **Exhibit A**.
- 3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment in the amount of \$48,277.00 from Bobcat of St. Louis for the Village of Dupo, Illinois.
- 4. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to make a one-time payment from Village funds in the amount of \$48,277.00, payable to Bobcat of St. Louis, for the purchase of a Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment for use by the Village for public purposes.
- 5. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase of said track loader, including but not limited to those contracts or agreements with Bobcat of St. Louis.
- 6. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase of the

Takeuchi TB235-2CR Excavator with an 18" Tooth Bucket attachment in the amount of \$48,277.00 from Bobcat of St. Louis.
