# AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS AUTHORIZING THE PURCHASE AND INSTALLATION OF A NEW ROOF ON VILLAGE HALL

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on November 19, 2018 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 8-9-1 of Article 8 of the Illinois Municipal Code (65 ILCS 5/8-9-1), any work or other public improvement which is not paid for in whole or in part by special assessment or special taxation and exceeds \$25,000 shall be constructed by contract let to the lowest responsible bidder; and

WHEREAS, pursuant to the provisions of Section 8-9-1 of Article 8 of the Illinois Municipal Code (65 ILCS 5/8-9-1) any contract for public improvement that exceeds \$25,000 may be entered into by the proper officials without advertising for bids if approved by two-thirds vote of the Village Board of Trustees; and

WHEREAS, the Village Hall is used for public purposes and the carrying on of the day to day functions of the Village of Dupo, Illinois and it is necessary that building/structure have a weather tight roof to protect the contents of Village Hall, including but not limited to Village files, documents, and equipment; and

WHEREAS, the Corporate Authorities has received a bid from Jim Taylor, Inc. of Belleville, Illinois to install a new roof on Village Hall for \$45,105.00 as referenced in attached Exhibit A—Jim Taylor, Inc. bid of 10/2/18; and

WHEREAS, the purchase of the new roof is for a public purpose, is within the Village's TIF District, and is to be paid for using TIF funds; and

WHEREAS, it is necessary that certain agreements/contracts be entered into with Jim Taylor, Inc. in order to effectuate the purchase and installation of the new roof at Village Hall; and

WHEREAS, pursuant to Section 8-9-1 of Article 8 of the Illinois Municipal Code (65 ILCS 5/8-9-1) and Section 1-2-17 of the Village Revised Code of Ordinances, bidding for the

aforementioned new roof was waived by a vote of two-thirds (2/3) of the Trustees holding office; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of a new roof for Village Hall; and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

- 1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois is authorized to purchase a new roof for the Village's Village Hall building/structure in the amount of \$45,105.00 from Jim Taylor, Inc., as indicated in **Exhibit A**, and any bidding requirement is hereby waived by a 2/3 vote of the Village Trustees.
- 3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase a new roof for the Village's Village Hall building/structure in the amount of \$45,105.00 from Jim Taylor, Inc., as indicated in **Exhibit A**, and the Village shall use TIF funds to purchase the new roof.
- 4. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase of the new roof for Village Hall.
- 5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase of the new roof for Village Hall from Jim Taylor, Inc., in the amount of \$45,105.00.
