#### ORDINANCE NO. 19-03

### AN ORDINANCE AUTHORIZING THE PLACEMENT OF TRAFFIC CONTROL DEVICES (NO PARKING SIGNS) ALONG LINDEMANN STREET IN THE VILLAGE OF DUPO, ILLINOIS

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1870 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on March 18, 2019 at 7:00 p.m., before the Village Board of Dupo and notice of said hearing was duly given; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-208(a)(1) to require the placement of "No Parking" signs to prevent drivers from parking on the southern side of Lindemann Street, starting at the 500 block and proceeding in an easterly direction to the end of Lindemann Street; and

WHEREAS, the Village wishes to prevent parking on Lindemann Street that would affect the operation of the Village of Dupo Splash Pad; and

WHEREAS, the Village has determined that the placement of "No Parking" signs on the southern side of Lindemann Street, starting at the 500 block and proceeding in an easterly direction to the end of Lindemann Street in the Village of Dupo, Illinois is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

<u>Section One:</u> The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

<u>Section Two</u>: The placement of "No Parking" signs on the southern side of Lindemann Street, starting at the 500 block and proceeding easterly to the end of Lindemann Street, in the Village of Dupo, Illinois is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.

<u>Section Three</u>: The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

<u>Section Four</u>: This Ordinance shall be in full force and effect from and after its passage and approval.
