AN ORDINANCE AUTHORIZING THE REMOVAL OF TWO TRAFFIC CONTROL DEVICES (STOP SIGNS) AND INSTALLATION OF TWO TRAFFIC CONTROL SIGNS (CROSS TRAFFIC DOES NOT STOP) ON CARONDELET AVENUE IN THE VILLAGE OF DUPO, ILLINOIS

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on June 3rd, 2019 at 7:00 pm, before the Village Board of Dupo and notice of said hearing was duly given; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-302 to designate highways within its jurisdiction as through highways;

WHEREAS, the placement of two stop signs controlling Eastbound and Westbound traffic on Carondelet Avenue is causing large trucks to damage Carondelet Avenue and thus, is currently creating an issue of traffic safety in the Village of Dupo; and

WHEREAS, the Village has determined that the removal of the two stop signs on Carondelet Avenue is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois; and

WHEREAS, the placement of two "Cross Traffic Does Not Stop" signs warning drivers that traffic on Carondelet Avenue does not stop will warn drivers traveling north or south across Carondelet Avenue and increase safety at said crossing.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

<u>Section One:</u> The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

<u>Section Two</u>: The removal of the Eastbound and Westbound stop signs on Carondelet Avenue is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.

<u>Section Three:</u> The installation of Northbound and Southbound "Cross Traffic Does Not Stop" signs on Carondelet Avenue is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.

Section Four: The various portions of this Ordinance are hereby expressly declared to be

severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section Five: This Ordinance shall be in full force and effect on and after June 18th, 2019.
