A RESOLUTION APPROVING THE TERMS OF EMPLOYMENT OF THE VILLAGE OF DUPO'S CHIEF OF POLICE PURSUANT TO AN EMPLOYMENT AGREEMENT

WHEREAS, the Mayor and Board of Trustees have reviewed the terms of employment of Kevin M. Smith as Chief of Police of the Village of Dupo as set forth in the Employment Agreement attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois as follows:

- 1. That the terms of employment for Kevin M. Smith as Chief of Police as set forth in the Employment Agreement attached hereto and made a part hereof as Exhibit A, is hereby approved and the Village Mayor and Village Clerk are hereby authorized to execute said Employment Agreement.
- 2. Kevin M. Smith shall be retroactively compensated for serving as Chief of Police for the Village of Dupo from June 1, 2019 to the present date, at a rate provided for in the attached agreement.

This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
