AN ORDINANCE AUTHORIZING THE CREATION OF A 3-WAY STOP AT THE INTERSECTION OF AUDRY STREET AND 5TH STREET; THE CREATION OF A 4-WAY STOP AT THE INTERSECTION OF TRANSPONT DRIVE/THIELMAN ROAD AND 5TH STREET; AND THE INSTALLATION OF A STOP SIGN AT THE INTERSECTION OF 410 TRANSPONT DRIVE, DUPO, ILLINOIS AND 5TH STREET IN THE VILLAGE OF DUPO, ILLINOIS

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on April 20, 2020 at 7:00 pm, before the Village Board of Dupo and notice of said hearing was duly given; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-208 to require the placement of a stop sign to assign right-of-way to traffic on certain approaches at any intersection of streets under its jurisdiction; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-302 to designate highways within its jurisdiction as through highways and erect stop signs or yield signs at specified entrances thereto, as well as designate any intersection as a stop intersection or as a yield intersection and erect stop signs or yield signs at one or more entrances to such intersection; and

WHEREAS, the lack of stop signs controlling the flow of traffic along 5th Street, specifically the intersections of: Audry Street and 5th Street, Transpoint Drive/Thielman Road and 5th Street, and an industrial drive way located at 410 Transpoint Drive, Dupo, Illinois and 5th Street is creating a public hazard due to the nature of traffic traveling along 5th Street; and

WHEREAS, the creation of a 3-way stop at Audry Street and 5th Street, a 4-way stop at Transpoint Drive/Thielman Road and 5th Street, and the placement of a stop sign at the intersection of the 410 Transpoint Drive, Dupo, Illinois and 5th Street will improve safety by controlling traffic along 5th Street.

WHEREAS, the Village has determined that the creation of a 3-way stop at Audry Street and 5th Street, a 4-way stop at Transpoint Drive/Thielman Road and 5th Street, and the placement of a stop sign at the intersection of the 410 Transpoint Drive, Dupo, Illinois and 5th Street is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE

VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

Section Two: The Village shall create a 3-way stop at Audry Street and 5th Street, a 4-way stop at Transpoint Drive/Thielman Road and 5th Street, and place a stop sign at the intersection of 410 Transpoint Drive, Dupo, Illinois and 5th Street.


Section Three: The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section Four: This Ordinance shall be in full force and effect on and after April 20, 2020.

PASSED this 20th day of April, 2020 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.


