ORDINANCE NO. 20-28

AN ORDINANCE PROVIDING FOR THE REMOVAL, REPLACEMENT, OR CONSTRUCTION OF A SIDEWALK ON SOUTH MAIN STREET, DUPO, ILLINOIS BY K.R.B. EXCAVATING, INC.

WHEREAS, the Village of Dupu, St. Clair County, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 11670 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupu, Illinois at the Dupu Village Hall, 107 N. Second Street, on November 16, 2020 at 7:00 p.m., before the Village Board of Dupu, and such meeting was held remotely due to the Governor's Executive Orders pertaining to the COVID-19 pandemic and pursuant to 5 ILCS 120/7(e)(4), and such allowed for remote attendance by the public and the Village Board; and

WHEREAS, pursuant to 65 ILCS 5/11-84-1, the Village is granted authority to provide for the construction and repair of sidewalks along or upon any streets or parts of streets located within the Village; and

WHEREAS, the Village has determined that it would be in the best interest of the welfare of the citizens and economic development of the Village to remove, replace, and construct the sidewalk located on South Main Street, Dupu, Illinois, beginning at the intersection of Firehouse Drive and South Main Street and continuing to approximately 195 S. Main Street; and

WHEREAS, due to the benefit to local businesses located on South Main Street, as well as the placement of the sidewalk on South Main Street, Dupu, Illinois, the Village authorities find that the proposed sidewalk shall be paid for with funds from the "Three Main Street Sales Tax Fund"; and

WHEREAS, the Village has received three bids from companies, offering to perform the removal, replacement, repair, and construction of the proposed sidewalk; Beckmann Construction Company bidding \$40,180.00; Heneke Excavating bidding \$36,211.35; and K.R.B. Excavating, Inc. bidding \$32,660.00. After review of the respective bids, the Village authorities have determined K.R.B. Excavating, Inc.'s bid of \$32,660.00 to be the lowest and best bid; and

WHEREAS, the Village has determined that the proposed removal, replacement, and construction of the sidewalk located on South Main Street, Dupu, Illinois, beginning at the intersection of Firehouse Drive and South Main Street and continuing to approximately 195 S. Main Street shall be performed by K.R.B. Excavating, Inc. for the amount of \$32,660.00. Said project shall be paid from the "Three Main Street Sales Tax Fund."

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS:

Section 1: Recitals. The aforementioned recitals are hereby adopted as findings by the Village Board and incorporated herein.

Section 2: Acceptance of Bid. The Village Board and Mayor find that K.R.B. Excavating, Inc. has submitted the lowest and best bid and therefore accept the bid proposal submitted by K.R.B. Excavating, Inc., to remove, replace, and construct a sidewalk located on South Main Street, Dupo, Illinois, more precisely located at the intersection of Firehouse Drive and South Main Street and continuing to approximately 195 S. Main Street, Dupo, Illinois for **Thirty-Two Thousand, Six Hundred and Sixty Dollars (\$32,660.00).**

Section 3. Authorization. The Mayor is hereby authorized to execute any and all contracts or agreements between the Village and K.R.B. Excavating, Inc. providing for the removal, replacement, and construction of the above described sidewalk. The Mayor is further authorized to make such payments from the "Three Main Street Sales Tax Fund" to K.R.B. Excavating, Inc., as may be required, but in accordance with the bid proposal submitted by K.R.B. Excavating, Inc, attached hereto as **Exhibit A.**

Section 5: Severability of Provisions. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.


Section 6: Conflict. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 7: Effective. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
