**AN ORDINANCE AUTHORIZING THE CREATION OF A 4-WAY STOP AT THE  
INTERSECTION OF LINDEMAN AVENUE AND 4TH STREET IN THE  
VILLAGE OF DUPO, ILLINOIS**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on July 6, 2021 at 7:00 pm, before the Village Board of Dupo, and such meeting was held in accordance with the Governor's Executive Orders pertaining to the COVID-19 pandemic and pursuant to 5 ILCS 120/7(e)(4), and such allowed for in person and remote attendance by the public and the Village Board; and

**WHEREAS**, the Village has the authority pursuant to 625 ILCS 5/11-208 to require the placement of stop signs to assign right-of-way to traffic on certain approaches at any intersection of streets under its jurisdiction; and

**WHEREAS**, the Village has the authority pursuant to 625 ILCS 5/11-302 to designate highways within its jurisdiction as through highways and erect stop signs or yield signs at specified entrances thereto, as well as designate any intersection as a stop intersection or as a yield intersection and erect stop signs or yield signs at one or more entrances to such intersection; and

**WHEREAS**, the lack of stop signs controlling the flow of traffic along 4th Street, specifically the intersection of Lindeman Avenue and 4th Street is creating a public hazard due to the nature of traffic traveling along 4th Street; and

**WHEREAS**, the creation of a 4-way stop at Lindeman Avenue and 4th Street will improve safety by controlling traffic along 4th Street.

**WHEREAS**, the Village has determined that the creation of a 4-way stop at Lindeman and 4th Street is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:**

**Section One:** The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

**Section Two:** The Village shall create a 4-way stop at the intersection of Lindeman Avenue and 4th Street.


**Section Three:** The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

**Section Four:** This Ordinance shall be in full force and effect on and after July 6, 2021.

**PASSED** this 6th day of July, 2021 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.


