**AN ORDINANCE AUTHORIZING THE VILLAGE MAYOR TO ENTER INTO A
MANAGED IT SERVICES AGREEMENT WITH COMPUTYPE IT SOLUTIONS FOR
THE POLICE DEPARTMENT OF THE VILLAGE OF DUPO, IL**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on July 6, 2021 at 7:00 pm, before the Village Board of Dupo; and

WHEREAS, CompuType IT Solutions provides managed IT services for support of workstations/laptops, firewalls, file server, data storage and preservation, software and computer system repair; and

WHEREAS, CompuType IT Solutions and the Village of Dupo wish to enter into an all labor included Managed IT Services Agreement for the Dupo Police Department computer systems; and

WHEREAS, the Village Board finds it in the public interest to enter into a Managed IT Services Agreement, all labor included, for one (1) year with annual renewal for the Dupo Police Department computer systems;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

Section 1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations and findings of the Village Board of Trustees of the Village of Dupo, Illinois.

Section 2. The Village Board of Trustees hereby approves the one (1) year labor included Managed IT Services Agreement with CompuType IT Solutions in a final form approved by the Village's attorney.


Section 3. The Village Board of Trustees hereby authorizes and directs the Mayor to execute, and the Village Clerk to seal, on behalf of the Village, the final Agreement with CompuType IT Solutions.

Section 4. This Ordinance shall be in full force and effect following its passage and publication in pamphlet form, as provided by law.


