**AN ORDINANCE AUTHORIZING A NO PARKING ZONE ON THE SOUTH SIDE OF
STONE STREET NEAR THE INTERSECTION OF 2ND STREET & STONE STREET
IN THE VILLAGE OF DUPO, ILLINOIS**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on November 15, 2021 at 7:00 pm, before the Village Board of Dupo, and such meeting was held in accordance with the Governor's Executive Orders pertaining to the COVID-19 pandemic and pursuant to 5 ILCS 120/7(e)(4), and such allowed for in person and remote attendance by the public and the Village Board; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-208 to require the placement of no parking signs to regulate parking that would inhibit sight lines to an approach at any intersection of streets under its jurisdiction; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-1303 to designate safety zones within its jurisdiction and erect no parking signs at specified prohibited parking areas and erect no parking at one or more sides to an intersection; and

WHEREAS, the lack of prohibited parking along Stone Street, specifically the intersection of Stone Street and 2nd Street is creating a public hazard due to the nature of traffic traveling along Stone Street and 2nd Street; and

WHEREAS, the creation of a no parking zone on the south side of Stone Street from the existing stop sign east one hundred (100') feet by placing no parking sign(s) will improve safety by controlling traffic along Stone Street and 2nd Street.

WHEREAS, the Village has determined that the creation of a no parking zone at Stone Street and 2nd Street is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

Section Two: The Village shall create a no parking zone on the south side of Stone Street from the stop sign east one hundred (100') feet near the intersection of Stone Street and 2nd Street.

Section Three: The various portions of this Ordinance are hereby expressly declared to be


severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section Four: This Ordinance shall be in full force and effect on and after November 15, 2021, and the placement of no parking sign(s).

PASSED this 15th day of November, 2021 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
