**AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN SURPLUS
PERSONAL PROPERTY OF THE VILLAGE OF DUPO, ILLINOIS**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on December 20, 2021, at 7:00 p.m., before the Village Board of Dupo and notice of said meeting was duly given; and

WHEREAS, the Mayor and Board of Trustees of the Village of Dupo, Illinois deem it advisable, necessary, and in the best interests of the Village of Dupo ("Village") and the public that it sell the following surplus personal property of the Village:

1996 AM General; Model: M998 HUMVEE; VIN# 101509

which is no longer necessary, useful, or in the best interest of the Village to retain; and

WHEREAS, the Corporate Authorities find that such property will no longer efficiently and effectively serve the public and corporate purposes for which the Village is organized, and such property is no longer reasonably necessary to conduct Village business; and

WHEREAS, pursuant to the provisions of 65 ILCS 5/11-76-4 of the Illinois Municipal Code, the Village is authorized to sell surplus personal property by such manner as the Corporate Authorities may designate; and

WHEREAS, the Mayor and Board of Trustees have determined that it will sell the surplus personal property by auction and that the auction service has received a final bid of \$20,800.00 for the aforementioned surplus property; and

WHEREAS, pursuant to the provisions of said 65 ILCS 5/11-76-4 of the Illinois Municipal Code, the corporate authorities of the Village may adopt an ordinance providing for the sale of said personal property; and

WHEREAS, the Corporate Authorities of the Village believe it to be in the best interests of the Village to sell the aforementioned surplus personal property via auction for the final bid received--\$20,800.00.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The aforementioned recitals are hereby adopted as findings by the Village Board and incorporated herein.

Section Two: The Village shall sell the above referenced surplus personal property by auction for the final bid amount of \$20,800.00.

Section Three: From and after the effective date of this ordinance the Mayor of the Board of Trustees and the Clerk of the Village are hereby authorized and directed to execute any and all necessary documents and agreements, and to do all things necessary and essential, including the execution of any documents, certificates, and title, to carry out the provisions of any agreement in order to sell the aforementioned surplus personal property of the Village.


Section Four: The Mayor and the Village Clerk are hereby authorized to accept an amount for the personal property that they both agree is reasonable and in the best interests of the Village and its citizens.

Section Five: This Ordinance shall take full force and effect immediately upon passage by the Village Board of Trustees.

PASSED this 20th day of December 2021 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
