### ORDINANCE NO. 22-02

# AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS AUTHORIZING THE PURCHASE AND INSTALLATION OF PAVILION IN THE VILLAGE'S MAIN STREET PARK

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on March 7, 2022, at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desires to purchase and have installed/constructed a public pavilion/shelter in the Village's Main Street Park; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois having received quotes for the purchase and installation/construction of a public pavilion/shelter desires to purchase from Erlinger Construction Co., Inc. of Belleville, Illinois ("Erlinger") said public pavilion/shelter and have the same installed/constructed by Erlinger for a cost of \$34,269.60, as referenced in Erlinger's quote attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the aforementioned public pavilion/shelter shall be used for public purposes by the public and citizens of the Village of Dupo, Illinois; and

WHEREAS, pursuant to Section 1-2-27 of the Village's Revised Code of Ordinances bidding for the aforementioned public pavilion/shelter was waived by a vote of two-thirds (2/3) of the Trustees holding office; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens and the public to

authorize the purchase and installation/construction of the public pavilion/shelter by Erlinger pursuant to those terms and conditions contained in Exhibit "A;" and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

- 1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois approves the purchase and installation/construction of a public pavilion/shelter by and from Erlinger for \$34,269.60 as referenced in **Exhibit "A"** at the Village's Main Street Park.
- 3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase and have installed/constructed the public pavilion/shelter from and by Erlinger for \$34,269.60 as referenced in Exhibit "A" for the Village of Dupo, Illinois.
- 4. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase and installation/construction of said public pavilion/shelter from and by Erlinger.
- 5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase and installation/construction of the aforementioned public pavilion/shelter at the Village's Main Street Park.

**PASSED** this 7<sup>th</sup> day of March 2022 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
