ORDINANCE NO. 22-04

**AN ORDINANCE AMENDING CHAPTER 38, ARTICLE IV, DIVISION II
OF THE VILLAGE OF DUPO, ILLINOIS' REVISED CODE OF ORDINANCES**

WHEREAS, the Village of Dupou, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupou, Illinois at the Dupou Village Hall, 107 N. Second Street, on March 21, 2022, at 7:00 p.m., before the Village Board of Dupou; and

WHEREAS, the Corporate Authorities (Board of Trustees and Mayor) having been informed and considered that the Village incurs expenses and increased employee labor hours when a water customer requests the Village to turn off and on their water service for various reasons, including but not limited to temporarily shutting water service off to make repairs inside a structure and then turning the same back on; and

WHEREAS, the Corporate Authorities believes that it would be in the best interests of the Village of Dupou to consider amending of Chapter 38 (Water System), Article IV (Rates), Division II, specifically, adding a new section, Section 38-4-12, of the Village's Revised Code of Ordinances that would pertain to "Other Water Charges," which would set forth the charges to be charged by the Village for requests received to turn off and on water service to customers; and

WHEREAS, the Corporate Authorities desire to amend Chapter 38, Article IV, Division II and create a new section, specifically, Section 38-4-12 "Other Water Charges," which shall read as follows:

38-4-12 OTHER WATER CHARGES.

Water Service Turn On and Turn Off: Any time a customer/person requests that the Village either Turn On or Turn Off a water service, the customer/requestor shall incur the following expense and shall be charged by the Village as follows: (i) During Normal Business Hours (7:00 a.m. to 3:30 p.m., Monday thru Friday): ~~a fee of \$200.00~~ ^{NO} shall be charged by the Village to the customer/requestor each time the water service is turned on or turned off; (ii) Outside of Business Hours, Weekends, and Holidays: a fee of Two Hundred Dollars (\$200.00) shall be charged by the Village to the customer/requestor each time the water service is turned on or turned off.

WHEREAS, the Corporate Authorities believe that the aforementioned amendment to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities recommends the approval of said amendment to the Revised Code of Ordinances of Dupo, Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS:

Section 1: Recitals. The aforementioned recitals are hereby adopted as findings by the Village Board and incorporated herein.

Section 2: Amendment. Chapter 38 (Water System), Article IV, Division II (Rate) shall be amended to add a new section, Section 38-4-12 Other Water Charges, which shall now hereinafter read as follows:

38-4-12 OTHER WATER CHARGES.

Water Service Turn On and Turn Off: Any time a customer/person requests that the Village either Turn On or Turn Off a water service, the customer/requestor shall incur the following expense and shall be charged by the Village as follows: (i) During Normal Business Hours (7:00 a.m. to 3:30 p.m., Monday thru Friday): ~~No fee~~ shall be charged by the Village to the customer/requestor each time the water service is turned on or turned off; (ii) Outside of Business Hours, Weekends, and Holidays: a fee of Two Hundred Dollars (\$200.00) shall be charged by the Village to the customer/requestor each time the water service is turned on or turned off.

Section 3: Severability of Provisions. Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

Section 4: Conflict. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.


Section 5: Effective. This Ordinance shall take full force and effect immediately upon passage by the Village Board of Trustees.


