

RESOLUTION NO. 22-22

**A RESOLUTION AUTHORIZING THE ENTERING INTO AN AGREEMENT
FOR THE PURCHASE OF RADIOS FOR THE VILLAGE POLICE DEPARTMENT**

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois (“Village”) at the Dupo Village Hall, 107 N. Second Street, on October 17, 2022 at 7:00 p.m., before the Village Board of Trustees of Dupo; and

WHEREAS, the Mayor and the Board of Trustees of the Village are desirous in upgrading the Village’s police vehicles with new radio technology to better serve the Village and the public at large; and

WHEREAS, the Village has obtained a quote for the purchase of eight (8) new radios for the Village’s police vehicles from Motorola in the amount of \$17,267.76, see attached quote labeled as **Exhibit “A”** and incorporated herein by reference; and

WHEREAS, the Mayor and the Board of Trustees of the Village hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to purchase the aforementioned eight (8) radios from Motorola pursuant to the terms and conditions contained in **Exhibit “A”**; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.

Section Two: The Village Board of Trustees hereby approves the purchase of eight (8) radios from Motorola pursuant to the terms and conditions contained in **Exhibit “A”** and authorizes the Mayor of the Village of Dupo, Illinois to take the necessary action to purchase said radios from Motorola, including but not limited to executing any such necessary contract for the purchase of the same.

Section Three: Each section, paragraph, sentence, clause and provision of this Resolution is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Resolution, nor any part thereof, other than that part affected by such decision.

Section Four: All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section Five: That this Resolution shall be in full force and effect from and after its passage and approval, as provided by law.

PASSED this 17th day of October 2022 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
