**AN ORDINANCE AUTHORIZING THE PLACEMENT OF TRAFFIC CONTROL DEVICES  
(THREE CHILDREN AT PLAY SIGNS, TWO STOP SIGNS) ALONG LINDEMAN AVENUE IN THE  
VILLAGE OF DUPO, ILLINOIS**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on May 15, 2023, at 7:00 pm, before the Village Board of Dupo and notice of said hearing was duly given; and

**WHEREAS**, the Village has the authority pursuant to 625 ILCS 5/11-208 to require the placement of "Children at Play" and stop signs to place drivers on notice of potential children who may enter the street; and further to notify drivers to stop for the protection of the public in general;

**WHEREAS**, the Village has determined that the placement of three "Children at Play" and two stop signs and one speed limit sign on Lindeman Avenue, Dupo, Illinois is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois. Specifically, the Village has determined that there is a need to add 2 new stop signs at Lindeman Avenue and 6<sup>th</sup> St. making a 3-way stop; to add "Children at Play" signs on Lindeman Avenue's North and South sides at 6<sup>th</sup> St. and 7<sup>th</sup> St.; and, to add a "Children at Play" sign 200 feet off of North 5<sup>th</sup> St. on Lindeman Avenue's South side.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:**

**Section One:** The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

**Section Two:** The placement of "3 Children at Play" 2 stop signs along Lindeman Avenue, Dupo, Illinois is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois.


**Section Three:** The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

**Section Four:** This Ordinance shall be in full force and effect from and after its passage and approval.

**PASSED** this 15<sup>th</sup> day of May 2023 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.


