ORDINANCE NO. 23-08

AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES OF THE VILLAGE OF DUPO, ILLINOIS, CHAPTER VII, ARTICLE VII, BUSINESS CODE, SECTION 7-7-9 AMENDING THE VILLAGE'S RAFFLE TERM AND FEES

WHEREAS, the Village of Dupo, St. Clair County, Illinois (the "Village"), is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on June 5, 2023, at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and

WHEREAS, pursuant to the Village's Revised Code of Ordinances, Section 7-7-9 the Village has established Term and Fess for Raffles; and

WHEREAS, the Mayor and the Board of Trustees of the Village ("Corporate Authorities") have determined that the Term and Fees for the Raffles are outdated and need to be adjusted; and

WHEREAS, after careful investigation, the Corporate Authorities have determined that it is necessary and in the best interests of the Village to increase the aggregate value of all prizes and merchandise awarded by a licensee in a single raffle to Five Hundred Thousand dollars (\$500,000.00) from the previous limit of Twenty-Five Thousand dollars (\$25,000.00) in subpart A; and raise the maximum retail value of each prize awarded by a licensee in a single raffle to Five Hundred Thousand dollars from the previous limit of Fifteen Thousand dollars (\$15,000.00) in subpart B while clarifying amending and adopting that: The values, price, and days set forth in divisions (A) through (D) of this section may be increased upon a showing of good cause by the organization applying for a raffle license and upon the approval of both the City Clerk and the Mayor; however, in no event may the maximum number of days in division (D) of this section exceed one year.

WHEREAS, the Corporate Authorities have determined that the Term and Fees be increased and amended as set forth in attached Exhibit A hereto and incorporated herein by reference; and

WHEREAS, the Corporate Authorities have determined that it is advisable and in the best interest of the Village to modify and amend Section 7-7-9 of the Village's Revised Code of Ordinances in the amended form attached hereto as Exhibit A.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS:

Section 1: The following recitals are incorporated herein as findings of the Board of Trustees of the Village of Dupo, Illinois.

Section 2: Chapter 7, Article VII, Section 7-7-9 of the Revised Code of Ordinances of the Village of Dupo, Illinois as adopted December 17, 2012, is hereby amended to read as follows:

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 4: This Ordinance shall take full force and effect immediately upon passage and publication in pamphlet form, as provided by law.

EXHIBIT A

7-7-9 TERM AND FEES.

The values, price, and days set forth in divisions (A) through (D) of this section may be increased upon a showing of good cause by the organization applying for a raffle license and upon the approval of both the City Clerk and the Mayor; however, in no event may the maximum number of days in division (D) of this section exceed one year.

- (A) The aggregate retail value of all prizes or merchandise awarded by a licensee in a single raffle shall not exceed **Five Hundred Thousand Dollars (\$500,000.00)**;
- (B) The maximum retail value of each prize awarded by a licensee in a single raffle shall not exceed **Five Hundred Thousand Dollars (\$500,000.00)**;
- (C) The maximum price which may be charged for each raffle chance issued or sold shall not exceed **Twenty-Five Dollars (\$25.00)**;
- (D) The maximum number of days during which chances may be issued or sold shall not exceed **one** (1) year;
- (E) Licenses issued pursuant to this Article shall be valid for **one (1)** raffle and may be suspended or revoked for any violation of this Code.
- (F) The Applicant shall pay a fee of Five Hundred Dollars (\$500.00) for each license.
- (G) The Local Liquor Control Commissioner may from time to time conduct inspections of raffle operations and if detrimental issues arise may suspend operation of the raffle until further notice.
