**ORDINANCE NO. 23-09**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS  
AUTHORIZING THE PURCHASE AND INSTALLATION OF POTABLE WATER FILTER SAND AND  
ANTHRACITE MEDIA IN THE VILLAGE'S WATER PLANT**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on June 5, 2023, at 7:00 p.m., before the Village Board of Dupo; and

**WHEREAS**, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desires to purchase and have installed Potable Water Filter Sand and Anthracite Media in the Village's Water Plant; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois having received two quotes for the purchase and installation of Potable Water Filter Sand and Anthracite Media desires to contract with TEK Construction & Excavating of Bartelso, Illinois ("TEK") and have the same installed by TEK for a cost of \$38,100.00, as referenced in TEK Construction's contract attached hereto and incorporated herein as **Exhibit "A"**; and

**WHEREAS**, the aforementioned Potable Water Filter Sand and Anthracite Media shall be used for public purposes by the public and citizens of the Village of Dupo, Illinois; and

**WHEREAS**, pursuant to Section 1-2-27 of the Village's Revised Code of Ordinances bidding for the aforementioned Potable Water Filter Sand and Anthracite Media was waived by a vote of two-thirds (2/3) of the Trustees holding office due to the emergent need and due to only two bidders engaging; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens and the public to authorize the purchase and installation of the Potable Water Filter Sand and Anthracite Media from and by TEK pursuant to those terms and conditions contained in **Exhibit "A;"** and


**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
2. That the Village of Dupo, Illinois approves the purchase and installation of the Potable Water Filter Sand and Anthracite Media for and in the Village's Water Plant from and by TEK for \$38,000.00 as referenced in **Exhibit "A"**.
3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase and have installed the Potable Water Filter Sand and Anthracite Media from and by TEK for \$38,000.00 as referenced in **Exhibit "A"** for the Village of Dupo, Illinois.
4. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase and installation of said Potable Water Filter Sand and Anthracite Media from and by TEK.
5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase and installation of the Potable Water Filter Sand and Anthracite Media.

**PASSED** this 5<sup>th</sup> day of June 2023 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.



TEK Construction, Inc has submitted a firm bid of \$38,100.00 to perform the work in accordance with the Curry and Associates, Inc letter dated May 16,2023, titled "Potable Water Filter Sand and Anthracite Media Installation, St. Clair County, Illinois".

Scope of Work is as follows:

- Remove and replace the media in three filters.
- Dispose of the media as specified.
- Cleanup as required.

Item specifically not included in the bid:

- If required, removal of the aggregate filter media with an air chisel or other device. It is assumed the vast majority of the media can be removed using a vacuum truck. Any additional work is to be compensated on a time and material basis.
- All media to be provided by the Village.
- Remove and replace filter nozzles.
