AN ORDINANCE AUTHORIZING THE INSTALLATION OF TWO TRAFFIC CONTROL SIGNS (STOP SIGNS) ON SOUTH 3RD STREET AND FOUR "4-WAY" TRAFFIC CONTROL SIGNS AT THE INTERSECTION OF LOUISA AVENUE AND 3RD STREET IN THE VILLAGE OF DUPO, ILLINOIS

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on July 3, 2023, at 7:00 pm, before the Village Board of Dupo and notice of said hearing was duly given; and

WHEREAS, the Village has the authority pursuant to 625 ILCS 5/11-302 to designate highways within its jurisdiction as through highways and stop and yield intersections;

WHEREAS, the lack of stop signs controlling Northbound and Southbound traffic on South 3rd Street is causing a hazard in the residential vicinity and thus, is currently creating an issue of traffic safety in the Village of Dupo; and

WHEREAS, the placement of two stop signs and the creation of a four-way intersection will increase the safety of the intersection of Louisa Avenue and 3rd Street by causing northbound or southbound traffic to stop.

WHEREAS, the Village has determined that the placement of two stop signs on South 3rd Street and four "4-way" signs at the intersection of Louisa Avenue and 3rd Street is in the best interest to public health, safety, and welfare of the citizens of Dupo, Illinois; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The aforementioned recitals are hereby adopted as findings by the Village Board, and incorporated herein.

Section Two: The Village shall place two stop signs on South 3rd Street, causing the Northbound and Southbound traffic to stop. The Village shall also place four "4-way" signs at each of the four stop signs located at the intersection of Louisa Avenue and 3rd Street.

Section Four: The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section Five: This Ordinance shall be in full force and effect on and after July 3, 2023.

PASSED this 3rd day of July 2023 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
