**ORDINANCE NO. 23-13**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, ILLINOIS  
AUTHORIZING THE PURCHASE AND INSTALLATION OF LPR CAMERAS**

**WHEREAS**, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on July 3, 2023, at 7:00 p.m., before the Village Board of Dupo; and

**WHEREAS**, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois (Village Trustees and Mayor) desires to purchase and have installed LPR Cameras for public safety; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois having received minimal quotes for the purchase and installation of LPR Cameras due to their unique nature but desires to contract with Utilitra and have the same installed by Utilitra for a cost of \$49,072.38, as referenced in Utilitra's contract attached hereto and incorporated herein as **Exhibit "A"**; and

**WHEREAS**, the aforementioned LPR Cameras shall be used for public purposes for the safety and welfare of the public and citizens of the Village of Dupo, Illinois; and

**WHEREAS**, pursuant to Section 1-2-27 of the Village's Revised Code of Ordinances bidding for the aforementioned LPR Cameras was waived by a vote of two-thirds (2/3) of the Trustees holding office due to the emergent need and due to only minimal engaging; and

**WHEREAS**, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens and the public to authorize the purchase and installation of the LPR Cameras from and by Utilitra pursuant to those terms and conditions contained in **Exhibit "A;"** and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Dupo, St. Clair County, Illinois, as follows:

1. That the recitals set forth above in the preamble of this Ordinance are hereby incorporated into this Ordinance as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
2. That the Village of Dupo, Illinois approves the purchase and installation of the LPR Cameras for and in the by Utilitra for \$49,072.38 as referenced in **Exhibit "A"**.
3. That the Mayor, on behalf of the Village of Dupo, Illinois, is hereby authorized to purchase and have installed the LPR Cameras from and by Utilitra for \$49,072.38 as referenced in **Exhibit "A"** for the Village of Dupo, Illinois.
4. That the Mayor, on behalf of the Village of Dupo, Illinois, shall execute and the Village Clerk shall seal, if necessary, such documents required for the purchase and installation of said LPR Cameras from and by Utilitra.
5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information and take any such further action as may be required to accomplish the purchase and installation of the LPR Cameras.

**PASSED** this 3<sup>rd</sup> day of July 2023 by the Village Mayor and the Village Board of Trustees of the Village of Dupo, St. Clair County, Illinois, and deposited and filed in the office of the Village Clerk in said Village on that date.
