RESOLUTION NO. 23 - 08

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, IL, TO AUTHORIZE THE VILLAGE MAYOR TO ENTER INTO AN AGREEMENT TO PURCHASE A 2023 FORD SUPER DUTY F-250 SRW XL FOR THE VILLAGE GAS DEPARTMENT

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on August 21, 2023, at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase real and personal property and equipment for public purposes pursuant to contracts that provide for consideration for such purchase to be paid through annual installments during a period not to exceed twenty (20) years; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois desire to purchase a Ford Super Duty F-250 SRW XL for \$58,487.26 for the Village Gas Department use; and

WHEREAS, the aforementioned Ford Super Duty F-250 SRW XL shall be used for public purposes by the Village of Dupo Gas Department; and

WHEREAS, three (3) competitive bids were obtained and Jack Schmidt Ford of Collinsville, Illinois was the lowest bid which was determined and accepted by the Village Board as attached in Exhibit "A" hereto; and,

WHEREAS, it is necessary that an agreement be entered into in order to purchase said truck; and

WHEREAS, funds are currently available for the purchase of the Ford Super Duty F-250 SRW XL; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase of a Ford Super Duty F-250 SRW XL for use by the Village of Dupo Gas Department; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois is to purchase a Ford Super Duty F-250 SRW XL from Jack Schmidt Ford in Collinsville, Illinois, as the lowest bid.
- 3. That the Mayor of the Village of Dupo, Illinois is hereby authorized to purchase the Ford Super Duty F-250 SRW XL for \$58,487.26 for the Village of Dupo, Illinois, on behalf of the Village's Gas Department.
- 4. That the Mayor of the Village of Dupo, Illinois, on behalf of the Village shall execute such documents necessary for the purchase of said truck.
