RESOLUTION NO. 23 - 14

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DUPO, IL, TO AUTHORIZE THE VILLAGE MAYOR TO ENTER INTO AN AGREEMENT TO PROCURE DASH CAMERA EQUIPMENT FOR TWO 2023 CHEVROLET TAHOES USED BY THE VILLAGE POLICE DEPARTMENT

WHEREAS, the Village of Dupo, St. Clair County, Illinois, is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a duly noticed public meeting was held in the Village of Dupo, Illinois at the Dupo Village Hall, 107 N. Second Street, on September 18, 2023 at 7:00 p.m., before the Village Board of Dupo; and

WHEREAS, pursuant to the provisions of Section 11-61-3 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-61-3), the Village of Dupo is authorized to purchase equipment for public purposes; and

WHEREAS, three (3) competitive bids were obtained and Turn-Key Mobile, Inc. of Jefferson City, Missouri had the lowest bid of \$15,492.00 which was determined and accepted by the Village Board; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois desire to purchase dash camera equipment for the two 2023 Chevrolet Tahoes used by the Dupo Police Department at a cost of \$15,492.00 as set forth on Exhibit "A" attached hereto; and

WHEREAS, the aforementioned two 2023 Chevrolet Tahoes shall be used for public purposes by the Village of Dupo Police Department; and

WHEREAS, it is necessary that the agreement be entered into in order to purchase said dash camera equipment to comply with the equipment necessary for police vehicles; and

WHEREAS, funds are currently available through the American Rescue Plan Act for the purchase of the dash camera equipment described fully in Exhibit "A" attached hereto; and

WHEREAS, the Corporate Authorities of the Village of Dupo, Illinois hereby find that it is necessary, advisable and in the best interests of the Village and its citizens to authorize the purchase the two dash cameras necessary to equipt the two 2023 Chevrolet Tahoes for use by the Village of Dupo Police Department; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. That the recitals set forth above in the preamble of this Resolution are hereby incorporated into this Resolution as recommendations of the Village Board of Trustees of the Village of Dupo, Illinois.
- 2. That the Village of Dupo, Illinois is to procure the dash camera equipment for two Chevrolet Tahoes for a total cost of \$15,492.00.
- 3. That the Mayor of the Village of Dupo, Illinois is hereby authorized to procure the dash camera equipment to equipt the two 2023 Chevrolet Tahoes for the Village of Dupo, Illinois, on behalf of the Village's Police Department.
- 4. That the Mayor of the Village of Dupo, Illinois, and on behalf of the Village shall execute such documents necessary for said purchase.
- 5. That the Mayor of the Village of Dupo, Illinois is authorized to provide any such additional information as may be required to accomplish the purchase of the dash camera equipment for the two 2023 Chevrolet Tahoes.
